**Calcium Gluconate Injection, USP 10% 100 mg/mL Vial
Supply Update**

Dear Valued Customer,

Fresenius Kabi Canada would like to provide the following supply updates regarding our **Calcium Gluconate Injection**.

As previously communicated, our **Calcium Gluconate Injection, USP 10% 100 mg/mL** 10mL and 50mL vials were expected to be on backorder starting March 1, 2022; however, we are pleased to advise that we have limited 50mL vials available. Understanding the challenges of using the 100mL vials to cover the 10mL demand on a mL by mL basis, we will be diverting all available 50mL inventory to cover 100% of the 10mL demand on a mL by mL basis. Subsequently, the 50mL demand will be covered by the 100mL as previously communicated.

Please note, **Calcium Gluconate Injection, USP 10% 100 mg/mL Vial 100mL** allocations are available **effective today, March 4, 2022**. Please see the table below for details:

*Please note, coverage is on a mL per mL basis based on historical demand. Please see below for examples of the conversion ratios:

5 vials of 10 mL = 1 vial of 50 mL
10 vials of 10 mL = 1 vial of 100 mL
2 vials of 50 mL = 1 vial of 100 mL

We strongly encourage all customers to use severe conservation measures across all formats of Calcium Gluconate available to extend the supply as long as possible. We are working diligently with our plants to expedite production and will advise of any updates should there be any improvements to the timelines and allocations indicated above.
