## Oxytocin Injection, USP Synthetic 10 USP units/mL SD Vial 1 mL and MD Vial 10mL Backorder and Short-Dated Notification

Dear Valued Customer,

Fresenius Kabi Canada regrets to advise that due to production delays, we are anticipating a supply interruption on Oxytocin Injection, USP Synthetic 10 USP units/mL SD Vial 1 mL effective October 1, 2022 to January 2, 2023.

Our <u>1 mL vial</u> will remain on 100% allocation for contracted customers until the end of September (based on historical demand). **Effective October 1, 2022**, allocations will then be **reduced to 50%**. Effective November 1, 2022, it is anticipated that our 1 mL will be on backorder as all inventory will have been depleted.

Pfizer is an alternate supplier of Oxytocin Injection Synthetic 10 units/mL 1 mL and they have been notified of our potential shortage. Pfizer has indicated that they have **limited inventory of their 1 mL ampoule** available and would **only be in a position to cover 50% of our monthly demand** during our shortage.

Our **Oxytocin Injection, USP Synthetic 10 USP units/mL MD Vial <u>10 mL</u> will be available with no restrictions until the end of September; however, all available inventory expires September 30, 2022. Due to the impending market shortage of 1mL vials we strongly encourage customers to use this short-dated inventory until expiry in effort to help conserve as much Oxytocin as possible. A limited quantity of 10mL with an expiry date of January 31, 2023 will then be available by October 1, 2022 and will be placed on 100% allocation. Contract customers will be allocated 100% of 10mL historical monthly demand with no coverage of 1mL possible. We anticipate fresh inventory of 10mL to be available by January 2, 2023.** 

The critical nature of this product is well understood and all efforts are being made to expedite production and mitigate this shortage. We will advise of any updates should there be improvements to the timelines indicated above. In the interim, we encourage all customers to use severe conservation measures across all formats of Oxytocin to extend the supply as long as possible.
