To our U.S. customers,

We are in the process of transitioning to new NDC numbers for our Enoxaparin Sodium Injection, USP Prefilled Syringes and Multiple Dose Vial. As requested by the FDA, these changes are being made to help differentiate Enoxaparin products that share the same concentration but have unique total strengths.

The table below outlines impacted presentations, new NDC numbers, and estimated release timing of new codes.
