Fresenius Kabi's Lidocaine HCl Injection, USP, codes will be on long-term back order because of an interruption in the supply of our Active Pharmaceutical Ingredient (API). We are actively working to qualify and secure a new source of raw material to bring these product codes back into regular supply.

The three Lidocaine codes set forth below will be impacted immediately with no future releases until an alternate API source is approved. All open orders for these codes will be cancelled.
